BACKGROUND

Haryana Rail Infrastructure Development Corporation Limited (HRIDC) has been set up by Ministry of Railway in accordance to the Union Cabinet decision dated 03 February 2016. HRIDC is a Joint Venture of Government of Haryana (GOH) and Ministry of Railway (MOR) having share of 51% and 49% respectively. HRIDC was incorporated on 22 August 2017 to develop rail infrastructure in the state of Haryana on the principal of cooperative federalism.

SCOPE OF WORK

Consultant shall assist the design unit of CBE/NR for review & approval of the structural design and drawings of substructure, pile cap, balance pile groups & other misc. items by analysis of the structural design and drawings submitted by HRIDC consultant. Consultant shall also carry out the required design checks in consultation & guidance of the design unit of Chief Bridge Engineer, Northern Railways.

TERMS OF REFERENCE

The purpose of this study is to facilitate review & check bridge designs and drawings submitted by consultant. All the plan and proposals will comply to IRS codes and Manuals, Indian Railways SOD 1676 mm Gauge, Good Engineering practice and related extant instructions issued by IR.

TERMS AND CONDITIONS OF THE CONTRACT

- 1. This contract shall be governed under Indian Railway General Condition of Contract for services (2018 edition) corrected up to date of opening of quotations.
- 2. The contract shall be valid for a period of 3 (Three) months which can also be further extended on satisfactory performance and mutual agreement.
- Consultant shall make his own arrangements at his cost for all materials and software required for execution, completion and maintenance of all items of work included in his scope of work to the complete satisfaction of the Railway.
- 4. Consultant shall make his own arrangements at his own cost for visiting Railway HQ, Delhi or HRIDC office at Chandigarh/ Gurugram or work site at Kurukshetra whenever required.
- 5. Copies of the structural drawing and structural design calculation done by the HRIDC Consultant shall be furnished by HRIDC. Approved General Arrangement Drawings and Geotechnical investigation report, pile load test and RSI study reports shall be supplied by the HRIDC.
- 6. The Consultant shall enter into and execute the Contract agreement in the form of agreement within 28 days from the date of issue of Letter of Acceptance. The stamp papers of the requisite value as per the prevailing laws shall be provided by the Consultant at his own cost. Original agreement shall be retained by the Employer/Engineer and a certified copy shall be made available to the Consultant.
- 7. Submission of Design & Drawings
 - a) The consultant shall assist CBE, Northern Railway office for review/approval of design of the pile foundation as found suitable as per soil characters, pile cap, pier, pier cap, trolly refugee, OHE arrangement, footpath, elevated station platform, shed, retaining wall and other allied structures.
 - **b)** The consultant shall also facilitate to review/approval of the drawings of temporary supports for slopes and temporary arrangements (enabling structures) for casting of super structure including erection scheme as submitted by designer.
 - c) The design shall be carried out conforming to the latest editions of Indian Railways Standard (IRS), Concrete Bridge Code (CBC), Bureau of Indian standards (BIS), Indian Road Congress (IRC) and, British Standards (BS), UIC Codes etc to the satisfaction of railway.
- 8. The payment shall be subject to deduction of income tax and other tax levied by the central/ State Government.
- Compliance of all statutory obligations and rules shall be ensured by the agency and claims against
 any liability falling on HRIDC due to non-compliance of statutory obligations by the contractor for
 any reason whatsoever would be borne by the contractor.
- 10. In case of any dispute of the interpretation on any clause in the terms and conditions of the contract, decision of Competent Authority will be final and binding on the contractor.
- 11. Approval of suitable extensions of time beyond the duration of the contract period shall be given by the accepting authority as per Indian Railway General Condition of Contract for Consultancy (2018 edition) corrected up to date of opening of quotation.
- 12. Price Variation & Mobilization Advance: PVC is not applicable in this contract and not payable to contractor. No any advance including mobilization is payable in this contract.
- 13. In case of any dispute jurisdiction of the court will be at Chandigarh.
