BACKGROUND

Haryana Rail Infrastructure Development Corporation Limited (HRIDC) has been set up by Ministry of Railway in accordance to the Union Cabinet decision dated 03 February 2016. HRIDC is a Joint Venture of Government of Haryana (GOH) and Ministry of Railway (MOR) having share of 51% and 49% respectively.
